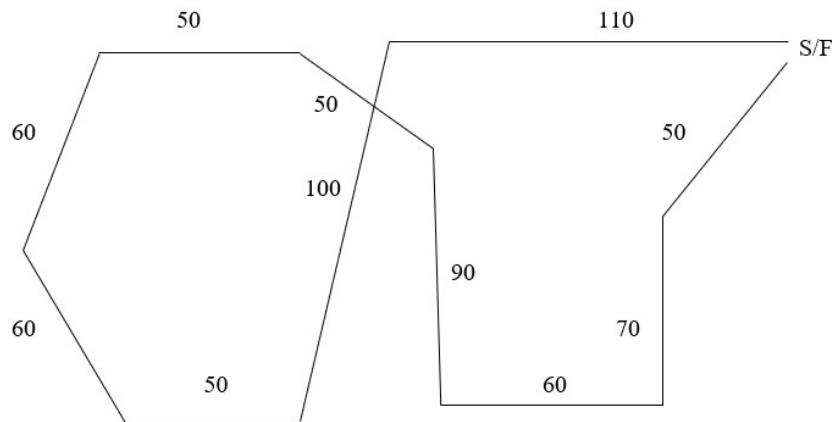

There will be a \$5 fine for a loose hound on the field that is not in the course in progress. The club reserves the right to alter the course as required by weather and/or field condition on the day of the trial. Courses will be reversed for finals and again for BOB.

#### **Directions:**

From South: I-75 to south of Dayton. Take I-675 (northeast) about 20 miles. Exit at Route 235 (Fairborn) and turn left on route 235 north. Go 0.5 miles and turn right at Yellow-Springs-Fairfield Road. Go 3.5 miles to the Park on the right.

From North/West: I-70 to east of Dayton, then exit on I-675 south. (ignore the route 235 exit off of I-70). On I-675 go south 3 miles and exit at Route 235 (Fairborn). Go right on route 235, north 0.5 miles and turn right at Yellow-Springs-Fairfield Road. Go 3.5 miles to the Park on the right.

From East: I-70 to west of Springfield, then exit on route 68 south (Xenia/Yellow Springs). On route 68 go south 6 miles, past Young's Dairy, and turn right at Yellow-Springs-Fairfield Road. Go 2 miles to the Park on the left. PLEASE NOTE THERE IS A LOW CLEARANCE BRIDGE ON THIS ROUTE THAT MAY NOT ACCOMMODATE RVS

The Brynmair Trophy, donated by the hounds of Brynmair, is in honor of the coursing Irish Wolfhounds past and present and to encourage the continued participation of those hounds who love the sport of lure coursing.

**Rhodesian Ridgeback — The Old Goat Trophy**

Donated in loving memory of Eve, Ch Windriver's Crimson Arrow CD LCM CGC ROM VC. Day-of-Trial entries closes 8:00 am EDST day of trial.**

All Hounds entering Open, Veteran or Limited Stakes for the first time MUST include a completed ASFA Certification Form or Waiver Form (with proof of title) and a copy of the hound's registration certificate (registration requirement waived for NGA Greyhounds only; certification waived for Single Stake entries only).

**Conditions of Entry:** All entries must be one year or older on the day of the trial. If the entry in any regular stake is 20 or more, the stakes will be split into flights by public random draw. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call and refunds provided. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at roll call will be scratched and no refund provided. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirnecho dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Espanol, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), and Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

**Any hound that has earned at least one ASFA point is eligible to enter. For a Provisional breed to be eligible, the entered hound must have received a placement, with competition. All points or placements must be earned by the closing date of the event. Any hound entered in the Singles Stake does not need prior ASFA experience. An eligible hound may be entered in any number of Regional Invitationals**

**Regular Stakes Offered**

**OPEN STAKE:** Any eligible sighthound who has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion of record.

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years and that have met certification requirements. Points earned in this stake are towards the V-FCH or V-LCM titles.

**PROVISIONAL:** Any eligible hound of a Provisional breed that has met certification requirements. Not eligible for Best In Field.

**SINGLES STAKE:** Any eligible sighthound including novice hounds and hounds with breed disqualifications and/or hounds that have been disqualified from competition in other stakes, are eligible to enter. Hounds are eligible to earn TCP and CPX titles from the Singles Stake. Provisional Breeds are not eligible for these titles. Not eligible for Best of Breed or Best In Field.

**Non—Regular Stakes Offered**

**BREEDER STAKE:** An entry shall consist of two hounds bred or co-bred by the same individual. Hounds must be entered in one of the regular stakes (Open, FCH, or Veteran). Scores of the two hounds will be added and the highest combined score will be awarded the Breeder Stake Award.

**KENNEL STAKE:** An entry shall consist of two hounds owned by and living with the same person. Hounds must be entered in one of the regular stakes (Open, FCh, Veteran). Scores of the two hounds will be added and the highest combined score will be awarded the Kennel Stake Award.

**FOR BREEDER AND KENNEL STAKES:** Entries may consist of the identical pairing of dogs, but each dog may only be entered once in each stake. Hounds are named at the time of entry by completing the attached form. Singles are treated as a "breed" unto themselves, therefore both dogs must be entered in singles to be in Breeder or Kennel Stake.

**Bench Stake:** For any hound eligible to enter a regular stake, that is an AKC, CKC, UKC or ASFA-approved international show champion of record. A copy of the hound's championship certificate must accompany each Stake entry.

**BEST IN REGIONAL** will be offered.
